

Establishment of the Authority of People with Disabilities

Initiative status

The Authority of People with Disability was established as a result of the lack of an official entity that enhances the services provided to people with disabilities, secures their rights related to disability, and ensures the necessary rehabilitation for them. The APD plays a major role in defining the roles of all service providers, which ultimately leads to the implementation of policies, strategies, programs, and goals for all projects that are concerned with people with disabilities.

Implementation of work programs in the national strategy for persons with disability

The Establishment of the Authority of People with Disability (APD) was one of the most important initiatives toward achieving this goal. Updating the National Strategy for Persons with Disabilities (Draft)

In the Authority's pursuit to achieve its objectives and tasks, the most important of which is the development of policies, strategies, programs, plans and tools that achieve the goals related to the authority's projects. including allocating what is related to persons with disabilities. Given the importance of providing a decent life for persons with disabilities in the Kingdom as well as a continuation of the efforts made in this regard and in a way that contributes to achieving the programs and goals of the Kingdom's vision, the authority updated the national strategy for persons with disabilities and prepared a comprehensive assessment to ensure compatibility with developments and changes in the local strategies and regulations

(e.g. Convention on the Rights of Persons with Disabilities and vision realization programs), and ensure that the Authority keeps up to date with worldwide developments in the best practices in terms of disability. The strategy was also based on aparticipatory methodology through which the inputs of persons with disabilities and their families were used, in addition to involving the main stakeholders and relevant authorities to design a comprehensive national strategy in which the vision, mission, pillars, goals and strategy are formulated, key performance indicators, initiatives and all related business frameworks and models such as the operational model, the governance model, the finance model, implementation plans, communication and risk management, to prepare a comprehensive strategy that reflects the ambition to provide a comprehensive and just society that provides a decent life for all persons with disabilities and quarantees their rights and promotes their active participation.

The most prominent works and achievements

Throughout 2022, the Authority of People with Disability continued to build and strengthen its institutional ecosystem and develop its legislative and organizational structure. The APD also sought to integrate and improve its services and achieve institutional excellence through an integrated and comprehensive infrastructure as well as human resources capable of achieving success.

In this section, we review the key works and achievements of the APD and explain their connection to the pillars.

The Unified National Register of Persons with Disabilities

The project aims to develop a unified system for the national register of persons with disabilities. This will enable the APD to collect information about persons with disabilities and their families to make the registry a reliable reference for the entities that provide services to such groups. The APD has completed the first phase of the registry and linked it with some entities and is currently working on linking it with more entities.

Some of what was accomplished in the first phase:

Developing a unified database for persons with disabilities that contains all the following information (social, health, educational, and occupational).

It is planned that the Authority of People with Disabilities will play a major role in the strategy as the body responsible and the focal point between various entities and their initiatives. The implementation of the governance model that the APD will supervise will contribute to ensuring the following

Appropriate supervision and direction which are needed for implementing the strategy.

Regular and instant inputs from stakeholders (including people with disabilities) which are needed for implementing the strategy.

Coordination at the sectoral level, promotion of joint efforts, and reduction in duplication of effort.

Oversight, at the sectoral level, will guide the overall implementation of the National Strategy for Persons with Disabilities, while integrated teams will be responsible for guiding the implementation of initiatives through an organizational structure to ensure continuous alignment.

The advisory structure ensures that all inputs of persons with disabilities and the private and non-profit sectors are included in all phases of the strategy.

It is worth noting that the National Strategy for Persons with Disabilities draft will go through the stages of approvals from the concerned authorities and may take some time.

A memorandum of understanding between the Second Airports Cluster and the **Authority of People with Disabilities**

The memorandum aims to raise awareness of the airport staff as well as find some solutions that help persons with disabilities be independent and benefit from the services provided them. This memorandum will contribute to educating society on disability through the various advertising outlets and specialized training programs.

A memorandum of understanding between The Authority of People with Disabilities and the General Commision for Audiovisual Media

The memorandum aims to improve the quality of services provided to persons with disabilities and conduct workshops that serve them, in coordination and communication with the relevant authorities. It also aims to raise awareness among the media employees on how to interact with persons with disabilities and the use of the approved term in Saudi Arabia.

Memorandum of Understanding between Umm Al-Qura University and the **Authority of People with Disabilities**

The memorandum aims to conduct scientific, applied, and technical research, as well as advisory specialized studies. It also aims to train and educate employees of the entities related to the Hajj and Umrah in order to serve and empower people with disabilities.











Current partnerships and agreements

Proceeding from the APD's role in defining the roles of all entities with regard to persons with disabilities, raising the quality of services provided to them, and enhancing their status, the APD signed a number of memorandums of understanding in 2022.

Memorandums of Understanding Signed In 2022:



A memorandum of understanding between the First Division League Clubs (FDL) and the Authority of People with Disability

The memorandum of understanding aims to raise the quality of services provided to persons with disabilities through the adaptation of stadiums as well as the provision of digital accessibility and appropriate job opportunities.



A memorandum of understanding between the Education and Training Evaluation **Commission and The Authority of People with Disability**

The memorandum of understanding aims to enhance joint cooperation between the two parties in the fields of training, research, and studies specialized in developing professional standards for teachers of persons with different types of disabilities.

Visiting disability related entities in Madinah, such as Taibah University, the Agency of the General Presidency for the Affairs of the Prophet's Mosque, and other entities, to learn about the services provided to people with disabilities and how to enhance and develop them.

Ministry of Health

Exploring health care services provided to persons with disabilities, ways to promote them, and appropriate solutions to current challenges.



Prince Sultan Center for Special Education Support Services

During the visit, the services provided to the beneficiaries were reviewed, ways of development and cooperation to better serve people with disabilities were studied, and possible solutions to current challenges were investigated.



Field Visits

The APD visited a number of government and non-profit entities in Saudi Arabia during the year 2022. The goal of these visits is to introduce the tasks and roles of the APD and improve the quality of services provided to persons with disabilities in coordination with the relevant authorities. The APD has set up visits to a number of entities in Riyadh, the Eastern Region, Qassim, Najran, Asir, Medina, and Tabuk.

In terms of achieving one of the APD's stipulated tasks, which is to represent the Kingdom in regional and international conferences, forums, seminars, and events related to disability, the APD participated in the following international events in coordination with the concerned authorities:

Responding to the Needs of Persons with Disabilities in Crises and Epidemics

The League of Arab States and the Ministry of Social Solidarity in the Arab Republic of Egypt, along with the Economic Committee and Social Council for Western Asia (ESCWA), put on the symposium. During the event, the APD gave a speech on behalf of the Arab delegations as the head of the current session (Session 41) of the Council of Ministers of Arab Social Affairs.

The Ministry of Social Development and Family, in collaboration with the Secretariat of the General Assembly of the League of Arab States—Social Affairs Sector (Department of Development and Social Policies), hosted the second workshop in the State of Qatar. During the workshop, the Kingdom shared its experience with classification and comprehensive evaluation through a representative from the Ministry of Human Resources and Social Development.

After the Shura Council recommended updating the 2000 Disability Code, the Authority of People with Disabilities drafted and revised the Rights of Persons with Disabilities Act. The APD followed the best international practices in the field of rights and regulations. This was reflected in the Rights of Persons with Disabilities Act, which included five chapters addressing education, health, functionality, physical accessibility, non-physical accessibility, culture, sports, entertainment, economic support, social support, and awareness-raising. Other important areas include Hajj and Umrah services, mosque preparation, transportation services, mobility, and other areas.

The Act shows that the Kingdom is meeting its international obligations under the Convention on the Rights of Persons with Disabilities. This includes recognizing a number of basic principles for people with disabilities, such as their right to represent themselves and be involved in disability-related issues; non-discrimination on the basis of disability; equal opportunities; and the inclusion of governmental and non-governmental legislation, strategies, policies, activities, programs, plans, and designs to meet the needs of persons with disabilities, as well as the right to access information through establishing the sign language as an official language.

The Act was sent to the Shura Council for approval after it was drafted. Legislative procedures are now being completed regarding the Act. The APD conducted a number of simplified studies related to persons with disabilities during the year 2022. Such studies cover topics related to disability in various fields, such as housing, promotions, retirement, transportation, and the rights of students with hearing disabilities. The APD raised several amendments to the housing and promotion procedures. The APD also held a number of meetings during which a number of aspects related to these topics were discussed with the concerned authorities.

Sixth Gulf Theater Festival for Persons with Disabilities

The Kingdom of Saudi Arabia hosted the sixth edition of the festival, which aims to include people with disabilities in social events and cultural and artistic activities. It also provides them with an opportunity to realize their dreams and share their talents and abilities in acting and theater arts.

Enhancement and Integration of Services

The Authority of People with Disability works continuously with the relevant authorities to raise the quality of services provided for persons with disabilities, such as education, treatment, rehabilitation, job opportunities, and access to public facilities and services. The following are the most prominent areas in which progress has been made with the relevant sectors in 2022:



Workshop: "From Compassion to Rights"

In order to enhance the APD's role in activating the roles of government agencies, a workshop was held under the title "From Compassion to Rights". Twenty-two (22) government entities were invited. The workshop targeted specialists in legal affairs to learn about the legislative and executive challenges facing government agencies. Two (2) persons with disabilities who work in the legal field were also invited. The participating agencies shared the obstacles they face in enhancing the services provided to persons with disabilities. The APD also shared its experience in the field of disability, expected goals, and recommendations.

The APD is working to share disability-related human rights knowledge with the relevant authorities, especially regarding accessibility in physical and digital environments. The APD is keen to enhance its role with government entities through the agreements.

The Circulation of the Emergency Evacuation Guide for Persons with Disabilities:

The Minister of Human Resources and Social Development and Chairman of the Board of Directors of the Authority of People with Disabilities, Eng. Ahmed bin Sulaiman Al-Rajhi, issued a circular to all government sectors stipulating adherence to the standards of the emergency evacuation guide for persons with disabilities. The APD created the quide in collaboration with the General Directorate of Civil Defense for the protection and care of people with disabilities as well as to maintain their safety in emergency situations.

Representation in the National Committee for Medical Rehabilitation

In order to develop the legislative and organizational structure, the APD joined the National Committee for Medical Rehabilitation, which is made up of several relevant bodies in the healthcare system. The committee aims to set the necessary legislation for the practice of medical rehabilitation services and submit proposals, studies, and scientific and technical advice regarding medical rehabilitation in its various specializations. Listed below are the most important tasks of the committee:

Preparation of national policies and standards and proposing procedural and technical rules in the field of medical rehabilitation.

Reviewing legislation and regulations for scientific and health medical rehabilitation and propose improvements.

Evaluating the current state.

Supporting research programs and determining the priority in the fields of medical rehabilitation.

Suggesting health programs and projects after they are studied by the commission.

Developing the health aspect of the national disability registry.

Education

Identifying and Classifying Students with Disabilities

The strategy of the initiative is to enhance, integrate, and improve the quality of services provided for people with disabilities. The initiative aims to achieve the strategic goal of improving equal access to education in order to achieve the integration of students with disabilities. The development of a framework to recognize and categorize all forms of disabilities and describe how they can access educational services through the school system will help achieve this. The initiative also aims to create a framework for identifying students with disabilities and putting them into groups based on the type of disability they have. This will help make sure they meet the specific requirements for general, higher, and vocational education. This will be done after studying the current situation and global benchmarking, as well as designing, publishing, and analyzing local survey studies on persons with disabilities. Such studies are considered basic references and baselines to examine awareness in the educational system and among education staff and prepare a standard framework for identifying and classifying students with special needs and disabilities in general, higher education, and vocational education, as well as a plan to launch training campaigns and raise awareness in the educational system. The expected outcome of the initiative is to raise awareness among parents, teachers, and the community about eligibility for educational services.

Work is currently underway on a series of workshops to harmonize operational plans within the framework of identification and classification, as well as plans for training and awareness campaigns with the Ministry of Education.

Workshop: «Fasih Initiative»

The workshop was held in partnership with Al-Muhaidib Group in order to enhance and integrate services and achieve the strategic goal of improving the quality of services provided to people with disabilities. The workshop was held on September 19, 2022, and aimed to provide early detection and treatment of language disorders for more than 10,000 children in various regions of the Kingdom. Moreover, provide training and awareness programs that contribute to the development of children's capabilities and reduce the negative effects of these disorders. A teleconference meeting was also held with the participation of a number of parties concerned with early childhood and people with disabilities to discuss possible ways of cooperating for the safety and health of the child in early childhood.







University Affairs Council Committee.

The Authority of People with Disabilities participated in a committee consisting of the General Secretariat of the University Affairs Council, King Saud University, King Abdul Aziz University, the Education and Training Evaluation Commission, the Undersecretary of Higher Education, the Department of Special Education at the Ministry of Education, and the Authority of People with Disability to study the development of the proposed arrangements for exempting people with disabilities from the Qudurat and Tahsili tests that are necessary for university admission.

Policy to Ensure Access to Education for Students with Disabilities Initiative Committee

The Authority of People with Disabilities participated in the committee, which aims to develop policies with the participation of the relevant authorities to accommodate students with disabilities in general, higher, and vocational education as well as in kindergarten and take their needs into account in all legislation, regulations, and projects to ensure their access to education in their area of residence.

Advisory Committee for the Initiative to Expand the Tests to Identify Gifted Students

The APD participated in the committee that aims to invest in and expand the discovery of talented people in all fields, such as cultural, scientific, sports, digital, and artificial intelligence, through talent detection tests and tools. This is done while ensuring harmonization and non-repetition of the current efforts to discover gifted students in the Education and Training Evaluation Commission and the King Abdul Aziz Foundation for Giftedness and Creativity (Mawhiba) and in alignment with the initiative to expand the Gifted Enrichment Program.


The Authority of People with Disabilities represented the committee for the return of scholarship students with disabilities based on the approval of the Royal Authority communicated by the telegram of His Excellency the President of the Royal Court No. (32270) dated 6/13/1442H regarding the transaction involving the Ministry of Education letter No. (152851) dated 23/11/1439H, referred to in the order of the Supreme Court No. (63248) dated 19/12/1436H, issued regarding the conditions of Saudi students with disabilities on scholarships.

It concluded with the following: the formation of a committee with members from the Ministry of Education, the Ministry of Human Resources and Social Development, the Ministry of Health, the Ministry of the Exterior, the Ministry of Finance, and the Authority of People with Disability (APD). The committee evaluated the experience of transferring cases of people with disabilities on scholarships outside the Kingdom to it in the first stage and directed the Authority of People with Disability to follow up on implementation and report to the Prime Minister.

Committee for the Establishment of Specialized Centers for Autism

The Authority of People with Disabilities was represented in the committee for the establishment of specialized centers for autism, which was directed in the Royal Court's telegram No. 51062, dated 17 Shaaban 1443H, which includes the approval of what the Council of Ministers directed regarding the establishment of specialized centers for autism. We inform you of the following:

The Ministry of Education will head the committee and represent a number of entities, while the responsibility of the APD is to follow up on the implementation of what was directed by the Council of Ministers.

The committee, under the chairmanship of the Ministry of Education as directed by the Council of Ministers and represented by the Ministry of Human Resources and Social Development, the Ministry of Health, the Authority of People with Disability, the Authority for Efficiency in Spending, and Governmental Projects, held two meetings on 25/10/1443H and 20/11/1443H. The participants included a representative of the Saudi Autism Society and a representative of the Autism Research Center at King Faisal Specialist Hospital, to learn about the studies and research that were carried out locally in the field of caring for children with autism.

The Authority of People with Disabilities launched the "Shadow Assistant" platform. It contributes to integrating people with disabilities into the labor market by providing supportive assistants for people with disabilities to help them adjust to their work environments and adapt to their colleagues.

Leadership Fundamentals Training Course

The Authority of People with Disabilities organized a training course entitled "Leadership Fundamentals" in cooperation with the Health Leadership Academy (HLA) that was established by the Saudi Commission for Health Specialties (SCFHS). The training course was delivered to a group of people with disabilities from various sectors, including the government and private sectors. It aims to provide the necessary tools to empower people with disabilities and help them succeed as leaders in their fields of work.

Economic Empowerment and Recruitment

With the goal of improving and integrating services, empowering people with disabilities, and increasing their full and effective participation in society, the APD, along with the Ministry of Human Resources and Social Development, the Ministry of Communications and Information Technology, the First Division League Association, the Red Sea International Company, and a number of private sector entities, contributed to the economic empowerment of people with disabilities. A total of 45 people with different types of disabilities were hired as part of the Future Skills Initiative, while 15 others were hired as part of the Initiative to Empower and Integrate Persons with Disabilities Who Benefit from Social Security, and one was hired as part of the First Division League.

Training and recruitment project for people with disabilities

In alignment with APD's role, which contributes to the empowerment of persons with disabilities and encourages their full and effective participation in society, the project is under way to train and recruit persons with disabilities. The project aims to achieve the following:



Information Technology

The Authority of People with Disabilities works to develop its electronic transactions on a regular basis to achieve the highest standards of commitment and maturity in digital transformation. Since then, the APD has sought, in cooperation with the Digital Government Authority, to raise the percentage of its digital transformation by 2022. It also achieved 25.25%, with an increase of 166% over the past year, 2021. The APD will continue to set goals to raise the rate of its digital transformation and cooperate with stakeholders to achieve them.

> The external and internal electronic portals of the APD were developed to ensure accessibility according to the best international standards and aim to:

Provide an integrated framework for services provided to people with disabilities.

Raise awareness of the rights of people with disabilities.

Availability of a service framework that shows the roles and responsibilities of each party.

Highlight the achievements and advertise the events and plans.

Shed light on the latest news of the APD, its goals, and plans.

Avoid duplication and unify the efforts of all entities.

The APD secured an advanced position in the first category in the incentive program for government procurement employees. The APD was recognized by the Government Expenditure and Projects Efficiency Authority (EXPRO), represented by the members of the APD's procurement committees.



During the year, the APD obtained position No. 47 in the fourth category among the winning government agencies, which numbered 75, as a result of the fourth quarter of 2021 and as part of the incentive program for government procurement employees that was launched by the Government Expenditure and Projects Efficiency Authority. The program aims to empower government entities and raise the efficiency of their procurement employees. It targets all employees of procurement in government entities that apply the Government Tenders and Procurement Law, including members of procurement committees in more than 450 main and subsidiary government agencies, according to the circular of His Excellency the Minister of Finance, Chairman of the Board of Directors of the Government Expenditure and Projects Efficiency Authority, No. 35386, dated 2-9-1443H.

Appropriate opportunities for the Authority

The Authority of People with Disabilities has many opportunities that have a sustainable impact on people with disabilities and the society in which they live, improving the quality of life, directly or indirectly, to create a decent life for people with disabilities and their families.

- Investing in advanced technical growth day by day, which is characterized by its flexibility, ease, and reliability, and employing it to serve the APD's beneficiaries in various sectors throughout the Kingdom.

- Achieving compatibility between the APD's goals and the objectives and programs of the Kingdom's Vision 2030.
- Organizing the APD, the tasks assigned to it, and granting it the ability and power to follow up on services and raise their quality, as well as create partnerships and agreements with the governmental, private, and non-profit authorities at both the local and global levels.

Challenges and Recommendations

Challenges:

After we reviewed the available opportunities in light of the current achievements of the Authority of People with Disabilities, it was also important to highlight the challenges. The APD is working with the concerned authorities to overcome the challenges and achieve its strategic objectives in accordance with the Kingdom's Vision 2030.

Unbalanced distribution of services at the regional level, a lack of integrated case management, limited inclusion of persons with disabilities in related strategies, and other challenges limit access to services.

Low level of public awareness and limited discussions about disability.

The lack of an integrated technical infrastructure for all services provided by government entities to persons with disabilities may delay the completion of the Unified National Register, which includes all data on persons with disabilities.

The complex system of entities related to persons with disabilities leads to overlaps and gaps without the adoption of governance or a centralized strategy.

Local and global trends aimed at enhancing the empowerment of people with disabilities, their integration into their societies, and the corresponding commitment from the Kingdom of Saudi Arabia through local programs and initiatives and international agreements.

The expected economic growth in the short and medium terms and the expected continued growth in allocated budgets for the health and social development sectors lead to enhanced quality in the services and programs provided by the APD to its beneficiaries.

Different resources of the APD, such as state budgets, endowments, private sector initiatives, and other resources, are invested in a better way to directly benefit the APD and its beneficiaries.

Through the APD's awareness and education efforts, there has been a radical shift in society's perception of people with disabilities, from pity and compassion to an awareness of their right to empowerment and integration with what benefits them personally, socially, and nationally.

Recommendations:

The Authority of People with Disability proposes a number of recommendations that can tackle these challenges and enable the APD to achieve its goals and vision for its beneficiaries, in cooperation with the relevant authorities, as follows:

Emphasizing the need for government entities to apply comprehensive accessibility standards based on the circular of the Chairman of the Board of Directors of The Authority of People with Disability No. (124990) dated 04/07/1442H.

Encourage entities to automate their services and provide data to link to the unified national registry, in addition to responding to the collection of any data related to the services provided for people with disabilities to issue the necessary reports.

Customizing a medical benefits package that is tailored to the needs of people with disabilities and gives them priority in medical insurance.

The lack of infrastructure readiness to achieve the goals of accessibility, both at the level of buildings, facilities, and public spaces or at the level of awareness of ways of implementation and its importance.

The lack of competence, training, and awareness of employees who interact with people with disabilities and a shortage of specialized and trained staff, especially in the fields of health and education.

Persons with disabilities fell behind their peers without disabilities in the areas of education, employment, and other major areas.

The lack of appropriate medical insurance coverage for people with disabilities.




